

Senior Barge Yard Manager - Riverside Thames Ltd

Cory is recruiting for the position of Senior Barge Yard Manager at Charlton. The company uses the River Thames as a green highway to move waste from London by use of tugs and barges, effectively removing 100,000 truck movements a year from London's roads to its Energy from Waste Facility in Belvedere, there generating electricity from residual waste, the facility is improving resource efficiency, avoiding landfill use and achieving greater sustainability as part of London's circular economy. Cory also operates a ship repair yard to maintain its fleet of tugs and barges along with maintaining third party vessels.

The primary purpose of this role is to efficiently oversee and manage the Cory Barge Works and Ship Repair Operations. Providing an effective maintenance and repair service to meet the demands of the company's in-house needs and to achieve an acceptable profit return on contracts for outside customers. They will provide overall operational managerial responsibility for the day-to-day operations at Cory Barge Works and overall managerial responsibility for the Ship Repair Operation and ensure full compliance with all legislation and terms of the site licences, contracts and agreements granted by respective authorities and legislative bodies.

Key Role Elements:

- Overall management of Cory Barge Works and Ship Repair Operations, including a Yard Manager directly reporting the day-to-day operations from the Ship Repair Operations.
- Manage ongoing and future procurement projects across both sites.
- Oversee contractor management across both sites.
- Compile and maintain annual budgets.
- Ensure both sites are complying with all necessary legislation Be proficient in the use of asset management software to create regular and accurate reports for other departments in the business.
- Personnel management across both sites, including but not limited to HR support, disciplinary and investigations, appraisals etc.
- Maintain and build strong commercial relationships with existing and new customers with the support of the Business Development Manager.
- Ability to provide accurate and reliable quotes and estimates for Ship Repair.
- Support and advise on wharf/marine maintenance projects where applicable across all Cory sites.
